1. **TulsipurSubmetropolitan City Office** invites electronic bids from eligible bidders for the construction of **Lukipur-Mallogau-Pipalbot-Daxingau-Dandagau to Main Road (Agricultural Road)** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs32,000,000.00 without VAT.**
 - Minimum Work experience of similar size and nature: **number of projectone (1) and value of each project 23,000,000.00 without VAT.**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00PM on January 07, 2021** at the office of **TulsipurSubmetropolitan City Office, Tulsipur-5, Dang**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 675,000.00**, which shall be valid for 30 days beyond the validity period of the bid. Or cash deposit in the Project's deposit account as specified below.
