6. The bids will be opened in the presence of Bidders's representatives who choose to attend at 14.00 hours on 31st day at the office of Tulsipur Sub-Metropolitan City, tulsipur, Dang. Bid must be valid for a period of 90(Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in the pdf format.
