- 6. The bids will be opened in the presence of Bidders's representatives who choose to attend at 14.00 hours on June 20, 2021 at the office of Tulsipur Sub-Metropolitan City, tulsipur, Dang. Bid must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in the pdf format. Bid security amount must be valid 30 days beyond bid validity period. Bidders may deposit Bid security amount in cash on Deposit Account Number: 0380010079178
